Ignoring this may result in compliance enforcement action and potential de-energisation of your embedded generation asset.

The Accelerated Loss of Mains Change Programme (ALoMCP)

We would like to inform you that if you own, or are responsible for, any generation assets at your site then your assets may require modification in line with mandatory changes to the G59 regulations within the Distribution Code.

WHAT YOU MUST DO

These changes impact the Loss of Mains protection settings that protect your generator and the wider UK electricity network from potential faults and ensure that the electricity system is resilient and ready to enable the UK's acceleration to net zero.

You are responsible for ensuring that your protection settings are compliant by 1 September 2022. Non-compliant generators cannot be tolerated due to the inherent risk that they pose to the United Kingdom's power supply.

Those not compliant from 1 September 2022 could be subject to enforcement that might result in the de-energisation of your generation site.

If you are unsure if your generation asset is compliant with the modification changes, please get in touch to discuss.





FUNDING IS AVAILABLE TO ASSIST WITH COMPLIANCE

FUNDING AVAILABLE

There is funding available to help you make the necessary changes. The Accelerated Loss of Mains Change Programme (ALoMCP) is an industry-wide initiative that helps generator owners, like you, to secure funding to make the system updates.

At the time of writing the ALoMCP provides two levels of funding:

- 1. If a protection device settings change is required, you will receive £1,500 for the first change, and an additional £500 per protection device up to a maximum of five devices.
- 2. If the protection relays require a full replacement, you can receive £4,000 towards replacing each relay.

However, your time to apply is running out. Funding will taper throughout 2022, with the last funding window closing on 10 May 2022. We urge you to act now.
